Understanding Your Visa Options: H-1B vs. OPT/F-1/CPT

OPT (OPTIONAL PRACTICAL TRAINING):

- Allows F-1 visa holders to work in their field of study.
- Standard OPT: Lasts up to 12 months.
- STEM OPT Extension: Additional 24 months for STEM graduates, totaling 36 months.
- CPT (Curricular Practical Training): Allows F-1 students to gain practical experience while completing their academic program.

H-1B VISA:

- A temporary visa for specialty occupations requiring specialized knowledge.
- Annual cap of 85,000 visas, leading to high competition.
- There were 470,342 applicants this year, equaling an 82% rejection rate.
